Society and Personality

This course will deal with some of those things we know about the individual and his human nature by virtue of his capacity to participate in social organizations and social interactions. Elementary social-psychological concepts will be presented, to be built upon and expanded as the course progresses.

The course will be divided into two parts, one hour of discussion and two hours of lectures a week. Required readings are selected from two books:
