I am reading your essay on early Goffman and enjoying it. This shapes up as a nuanced, important statement that you might wish to publish at some point, certainly add to the Goffman archives when you think it is ready to be shared.

Nice excavations related to Fran's early success on stage, the Dauphin clothing store, Jewish history in Canada, and more. The paper fills a few gaps and raises intriguing questions, substantive as well as methodological. I always felt that the EGA can illuminate how memory works, documents are created, historical facts mis/framed by engaged interpreters. I hope you will develop your thoughts on "contradictory evidence" at length in the future.

The culture-personality framework is a good fit for your analysis. I would add that in cases of odd-ball-geniuses like Goffman, this is a two-way traffic, the person's response reflects the singularities of the individual while his personality may leave a mark on culture.

I like your reflections on vaudeville, slapstick, and one-upmanship. EG was exposed to that mode early on, and probably not only through theater. The link you draw between EG's urge to upstage and his youth experiences is convincing.

Occasionally, you bring up a few little-known facts without mentioning the source (that EG family moved to Dauphin in 1926, that the family relocated to Winnipeg in 1937, and so on). Since not much is known about the dates and circumstances, it might be helpful to indicate the source. You can offer a more detailed overview of the available sources, their strengths and weaknesses.

I see that you plan to add a methodological appendix – good! Nice agenda setting for future work. You need a consistent reference system when you cite EGA materials (e.g., "Goffman Bay, EGA" or something along those lines), so the reader knows where to find the text you cite. It would help if you spell out the abbreviations.

A few minor typos:

- p. 7. "Ely Bay" should be "Eli Bay"
- p. 9. "Goffman Bey" should be "Goffman Bay"
- p. 10 "His is sister remembers" should be "His sister remembers"
- p. 18. "The adolescence Erving became remote" should be "In (or during his) the adolescence Erving became remote"

Greetings Esther:

It was good talking to you, as ever.

Following up on our conversation, I want to sound Frances on the possibility of setting up the Erving Goffman Fellowship. The idea is yet to jell, but I am thinking of putting down \$15,000-20,000 seed money and look for ways to match it by appealing for small donations (\$25-100) from Erving's students and interested scholars. If we can raise something close to \$50,000, we can offer \$3,000-4,000 to a graduate student working in the Goffman tradition and doing research developing his ideas.

The fund will be administered by the University of Nevada and the board of the Goffman Archives. Students applying for a grant would submit a resume, a writing sample, and a proposal that will be reviewed by EGA board members. The winner will be expected to furnish a paper with the research results deposited in the Goffman archives.

That's pretty much it. If you think it is a good idea, bring it up with Frances to see if it makes sense to her. Please emphasize that we are not soliciting money from Fran or anyone else related to Erving. I am not sure if this initiative ever gets off the ground, but it's a thought.

Hi Michael

Dmitri sent me your Goffman bio documents and they arrived just as I was in the midst of doing the citations on my paper (ugh!) so I read your material with a lot of interest. As I mentioned in my paper at the Stone-Couch symposium, the archives are a valuable resource on what is known, assumed, and claimed about Erving Goffman, as a boy and as a man, as well as a sociologist. There are many other sources that supplement those documents and help give them context and meaning. But any number of readings can be made.

Your biographical sketch is an example of such a reading of the archive, although it is a bit sketchy for me. I wish you had introduced some reason, some statement of objective that would frame the descriptions you presented, why you focused on what you selected, what guided your sociological imagination. And it seems rather uncritical, rather idealized---where the respondents' descriptions of, for example, how awesome Auntie Anne is taken as how awesome auntie Anne was. Nothing supports or questions those statements, not even a caveat as to how those documents were put together in the first place, why the respondents might have said what they said.

While most of it is not news to me, some of it is. In particular, you cite Frances as saying the family spoke Yiddish. I re-reviewed all the relevant documents in the archive and I cannot find where this is stated. So I would appreciate if you would cite this, as I would like to follow up on it. Early language influence in the the family is something I have sought out, and asked Dmitri to ask Fran on the second time he talked with her.

- 4. Did Max and Anne speak Russian at home? [we learned they did not speak Yiddish]. Where/when did they learn English? Did they speak well?

Fran and Esther recall Max and Annie talking English, not Yiddish or Russian. Perhaps the last two languages slipped out of use by the time the couple moved to Dauphin. Esther says it is conceivable they would speak Russian if they didn't want kids to understand, but she recalls nothing of the kind.

Second you say the Goffmans were at the "upper end" of the class structure, while Fran suggests a much more modest social class for the "family of orientation," as the anthropologists would say, and the combination of Max's education and occupation (leaving aside that we know nothing of his income) would suggest even more modest class position.

---From Frances' memoir,

Shalin: That's all right. You say your family was comfortable. Would you say you were middle class?

Bav: Yes.

Shalin: Upper-middle class? **Bay:** Middle class Jews.

Brownstone says the Goffmans were Bourgeoisie, but given Brownstones political world-view, he may be using that term to refer to their politics rather than their socioeconomic status. Winkin gives no source for his claim that Max owned a number of stores and the Averbach family album, which gives considerable attention to various members economic enterprise, only mentions Max's store in Dauphin.

Katz says the Goffmans were wealthy, but this was a judgment made from the eyes of a five year old about his friend's family status.

I think Erving started his early years as petit-bourgeois, and that is a very different status than bourgeois. His father was an uneducated shop keeper* who provided for his family through hard times, but that does not make the family middle-class in the Warner scheme of things---a scheme Erving studied and used in his research later. While Erving might not have fully appreciated being petit-bourgeois when he was, he certainly had the opportunity to look back at his own modest beginnings in those terms. Anyway, I make a big deal of this question of SES and will send you a copy when I finally get it more or less properly cited.

I hope this does not come across as critical in some proprietary way but rather as some questions and suggestions.

I still think you need a paragraph or two setting out what your objectives are, and something at the end pulling it together and indicating where you are going. That is just my thinking. What you wrote to me, for example.

It is true that what I have been doing (beginning with a first draft in December, 2008) has been more explicitly a sociobiography, limited to Goffman's childhood and youth, drawing from a variety of sources beyond the EGA, looking at what we know (or think we know) and putting those details into a larger social, cultural and historical context. I do not propose that his childhood and youth "explain" his adult behavior; rather that this is one part of his life story. In the process I realized that I also need to write a methodological appendix, explaining how and why I did what I did in coming to the conclusions I draw---including questioning sources. For someone who has not thought of herself as a sociologist for almost a decade, I am a little meshugana for taking this on.

Perhaps I should use Warner's actual "lower middle class" term instead of "petit bourgeois," although I have to admit a special fondness for all the connotations of the latter. Social class is not determinate. Neither is any other singular variable. But issues of "social class" are relevant to understanding Goffman's youth and certainly they were of specific concern to him when he began his sociological work.

I have reformatted your article according to the SI specifications (see attachment). You might want to go over these guidelines and see what else needs to be added – an abstract (no more than 100 words), word count, full address and contact info.

I made minor changes related mostly to punctuation to align the style of all papers with the SI format. For instance, I added a coma in sentences like this one: "In Winnipeg, Max met Ann Averbach," and changed square brackets to the round ones where you referred to a source: "Max was absorbed into this social world (Zaslov)." The final word on those things belongs to a copy editor.

The SI convention is to give the author's name and the year of the publication/source, (e.g., Tucker 1970). I provided the year alongside the author's name, but you need to double-check that. Also, the last name of the author should appear before the first name in the reference section (so I changed things accordingly), and all sources should be listed in the alpha order.

Some authors cited in the text do not appear among the references (e.g., Katz; Sartre; Vidich and Bensman). "Winkin 99" should be clarified as to its source.

Here is a link to an article recently published in *SI* that you can check for the citation format, http://onlinelibrary.wiley.com/doi/10.1002/symb.47/pdf.

EGA interviews appear without the year in the text. I wonder if it makes sense to provide the year that the interview was posted – info on that is available in the intro section to each interview. Also, it is better not to repeat the full reference to *Bios Sociologicus* each time you list an interview in the reference section. You can list this general source once, provide the abbreviation for it (e.g., EGA), and then insert this abbreviation after you list the author and his/her interview title in the reference section.

There is a line at the end of the paper which should not be there, yet I cannot eliminate it.

I see that some of the titles appear in the text as hyperlinks – I doubt this is necessary.

Thanks again for the valiant work you have done putting together this important paper.

On the controversy surrounding Max Goffman's income, I would cite Leonard Syme's interview posted on our site, http://cdclv.unlv.edu//archives/interactionism/goffman/syme_11.html. Here is the relevant exchange:

Syme: Max was really brilliant. He had investments, he was a millionaire.

Shalin: Do you know this for a fact?

Syme: Well, he owned like 25 buildings. Money that Fran [Goffman Bay] had was partly her own, partly from Chuck, and I think they still were living on Max's money. He invested right, he made a lot of money, but he was not very impressive in an intellectual sense.

I don't see why not make a brief reference to Syme's view in the body of the text. But you can place it in the footnote if you like. You can also reference Winkin's article. And you can cite Winkin on EG and girls. As for "bit part" or "small part" that Goffman played in Hamlet, I don't see much difference. What matters to Dingwall is not the size of the part but its meaning. He thinks EG might have been assigned this part of a jester for a reason. Small is fine with me.

If that is the picture from my paper it came from the Averbach family album---Erving' maternal family---and I was given permission to use it by Esther Besbris, an Averbach. When you requested further permission for Symbolic Interaction and said you would contact Esther, I assumed you did and that any publication of those pictures would be properly attributed to the Averbach family, as they are in my paper.

I doubt if any of the living Goffman family---which is only Alice since Gillian remarried [and] is now part of some other family---has ever seen those pictures much less given you or me or *Symbolic Interaction* permission to publish them. So why claim they have? Why make an issue when there need be none?

There is a part of me (the part that studied with Garfinkel) that says, okay, let Dmitri do what he wants; if this makes trouble, that will be interesting. But I want to register my objection one more time. The correct attribution of **that** picture is courtesy the Averbach family; the claim that that particular picture came courtesy of the Goffman family does not stretch the truth. It is an untruth which can be easily corrected. And from my perspective should.

The important thing is to meet the publisher's needs without offending other family members.

Dimitri, Esther B. is Erving's cousin. This is not difficult to explain.

"not the immediate family" Hey, Erving had a mother; she is his mother's sister's daughter. Does the maternal line have no rights?

I don't know what anthropological kinship system you are arguing from but I am really bothered by this marginalization of his maternal family.

Gillian is no longer in "the immediate family" she remarried; she belongs to another family. She may be the executor of Erving's estate; but that is a different matter than being in "the immediate family". This picture did not come from the Goffman estate: it came from the Averbach estate.

<...> This picture came from the Averbach family album and DV, a copy of which Marly and Esther so generously provided to you and to me.

Actually, if the publisher wants to be hard line copyright law gives the right to this picture (and any other) to the photographer and if deceased to the photographer's estate, http://www.legalgenealogist.com/blog/2012/03/06/copyright-and-the-old-family-photo/

This particular use of this image of Goffman is for purposes of publicity and PR does not require any statement to be verifiable; you can say pretty much what you want. The rules for ethnography are not the same. I will let the matter drop and you and Dingwall can do what you want in the name of publicity. I do not expect any change in the acknowledgments and permissions cited in my paper.

better than the mediocre mysteries I have been reading this summer.

At first I thought maybe this brouhaha is all a Goffmanesque experiment to show how far name recognition can take you beyond what would be insurmountable obstacles to others. Improbable, yes. But I also find accusations of fraud and chicanery on the part if this young sociologist also improbable.

If AG took the accounts people told in her presence as the equivalent of observing the events themselves a lot of her "mistakes" about the legal/police system make sense: they reflect how her informant views the world and not her view of her informants acting in the world.

Two examples: did AG participate in a night time crap game in the ally or did a participant in that occasion relate the events to her?

Was AG in the maternity ward to observe Alex being dragged away and the new mother crying out or again, was she the recipient of this account? (It is hard for me to believe that the hospital would include the ethnographer's presence as a legitimate part of the family unit, having full access to the maternity ward. When I

was a graduate student the big joke was that an Eskimo family included a mother a father, their children and ethnographer. And when studying hippie capitalists I used to be introduced as "my Ethnographer"...often without a name!

Maybe not distinguishing between what is observed first hand and what is an account of the people you are observing is a gloss, a way of making the narrative more interesting, more dramatic. But it is not sound ethnographic practice and I cannot believe her committee passed on that in her dissertation. Yet it is quite believable that her copy editors at UChicago press believed it would make the book more marketable, as it did. The answer of course is in the comparison of the dissertation and the book which, like her field notes, is unavailable. And I really fault her copy editors for not clarifying the time lines and catching obvious contradictions.

Immersion in the field is what gives the ethnographer access to the participant's accounts of their world view and the opportunity to observe their common practices. But again there is a difference between the account of the event, with its inherent bias of whoever tells the tale (along with the biases of the ethnographer) and the account of the event as witnessed directly by the observer, who naturally brings along various view points, generally described as "biases" by people who hold different view points.

<...>, I am going to forward your e-mail to Dmitri and ask him to respond, which I am sure he will do.

However, let me speak to what I know. When Dmitri first proposed the archive he contacted everyone he thought could/would contribute to this project. As a student of Goffman, I became enthusiastically involved because i really believe that our biography is reflected in our work, because nowhere in sociology was there a project that explored in detail (although some did superficially) the biographies of those whose work created our discipline, what their experiences brought into the ideas we take for granted, how they came upon those ideas.

Some people contacted were as enthusiastic as I, some were mildly interested and could be encouraged to participate, others were indifferent, and some were opposed. I put Howie Becker (who was a long time friend of Erving's) in the indifferent category. I had a number of long conversations and e-mail with him; his position was that he was not opposed to the project but he would not participate. There possibly were others; Dmitri would know.

A good part of what opposition there was to the project was that Dmitri was an outsider and had no "claim" to the Goffman legacy.

Rather than opposition, Erving's family (his sister, his cousins, his son) were all enthusiastic about helping and went out of their way to provide documents, interviews, permissions, etc.

Gillian (although not Bill) was contacted but never responded, neither with support nor opposition. Alice was never contacted.

Anyway, if you feel at all uncomfortable about participating in the project we will remove your memoir immediately.

I certainly did not want to introduce any gratuitous drama in inviting you to participate and hope we can clarify things for you.

I understand <...>'s concerns, his unwillingness to cross EG's family if some of its members are unhappy with EGA. You summed up the arguments in favor of the archives well.

A number EG's relatives do indeed support the project, some contributed memoirs, documents, and photos. The same is true of many EG's friends, students, and colleagues. The documents collected in EGA have historical value, some are quite unique. Witness accounts collected there would not have been preserved were it not for our collective efforts. The SI special issue devoted to EG and EGA went through a thorough review before it was published, suggesting the project has an intellectual heft.

I should add that I met with Gillian at Frances Goffman's home and we talked about this project. I showed Gillian the youthful photos of EG that Frances and Esther Besbris, Erving's cousin, gave me. Gillian gave no indication that she was opposed to the project.

When Elizabeth Bott, close friend of Erving's, sent me her memoir about EG, she asked me to show it to Gillian, Tom, and Alice and make sure they are on board with making it public. After I did as she requested, Gillian wrote to me that she was fine with this memoir to be added to EGA. Tom Goffman did the same. I have not heard from Alice but Gillian indicated that she was aware of [the memoir].

Hope this helps to put things I perspective.

After all, it was Erving who introduced the whole idea of "backstage" and made us aware of the role it plays in our pubic performances.
